SUPERINTENDENT REPORT

My word for this month is preparation – The action or process of making ready. In looking at this word, I find the job of schools. We are taking action to get our students ready to be successful adults. Starting with our mission statement to develop productive citizens who are enrolled, enlisted, or employed at high school completion.

To fulfill our mission, we must get our students to school. I must thank the administration, teachers, and staff for their work in the first semester to improve our attendance rate. We had improvement in both student and staff attendance. The administration has ensured accountability, the teachers and staff members have improved relationships with students and set the expectation that students need to come to school.

Besides improving attendance, the district has had an improvement in student behavior. The Board of Education's change from Deans to Discipline administrators has significantly impacted the buildings' cultures. The discipline administrators have done a great job working with students and staff to create the hallways, classrooms, and schools we expect. The work hasn't been easy, but it is appreciated.

The principals, in conjunction with the discipline administration, are currently sending out and reviewing data on safety in our buildings. It continues to improve. Our focus in the first semester was to improve safety and behavior. We feel like we are well on our way. We will be working to keep the gains that we have made and to increase safety in the buildings as we start projects to improve instruction. We don't say that lightly or to throw shade on our teachers. We have good teachers, but we can all improve, and the more skilled we are in teaching, the more students that we can assist. We want to ensure all students are enrolled, enlisted, or employed at graduation, so we must continue to improve.

Our final step will be working on additional curricular improvements. With the focus on answering the four important questions of (1) what we want all students to learn (by course) (2) How will we know when they have learned it (assessment) (3) What will we do when they haven't learned it (for remediation) and (4) What will we do if they have already learned it (enrichment). Mr. Fickes and his team are working to develop a system that ensures these things are done collaboratively. To do this, we must consider some changes.

The major change we must consider is scheduling. We need more time for professional development. We must be able to collaborate on lessons, assessments, and classroom expectations. We are considering some minor schedule changes that will allow us to do this without disrupting the student day, parent responsibility, or the labor contract. We will be bringing these recommendations in the next sixty to ninety days.

We thank the board, staff, and community for all the support in making changes that continue to positively impact our students and their learning. Thank you for your time and attention.
