Professional Qualifications and Assignments

F. In order to prepare for annual reviews and to meet with caseload students, the special education teachers will be provided two (2) days per semester of release time as mutually agreed upon between the administration and teachers. The teacher must remain within their assigned building during release time hours.

Article 13 F- Extracurricular Activity Supervision

F. All certificated professional employees will assume supervision of a maximum of one non remunerative extracurricular activity of the school assigned by the principal or his representative. ~~No certificated professional employee shall be assigned to supervise or chaperone a social activity during a school holiday. A school holiday shall be defined as beginning at the close of the regular school day on the last day before the holiday, and ending on the opening of the regular school day after the holiday. Any assignment necessary during a holiday period will be on a voluntary basis.~~ By October 1st, the activities director will submit extracurricular activity assignments to the principal or his representative, who will then submit assignments to all licensed professional employees.

1. A list of activities will be presented to the staff so that they may make a selection. Every effort will be made to accommodate those choices.
2. If a staff member does not select a chaperone assignment, then the activities director will assign one.
3. Counselors will be assigned to graduation as their chaperone assignment.
4. If an activity is cancelled, then the chaperone assignment will be considered fulfilled by the staff member.
5. No certificated professional employee shall be assigned to supervise or chaperone a social activity during a school holiday. A school holiday shall be defined as beginning at the close of the regular school day on the last day before the holiday, and ending on the opening of the regular school day after the holiday. Any assignment necessary during a holiday period will be on a voluntary basis.
6. No certificated professional employee will be required to chaperone on a Sunday.

ARTICLE FOURTEEN
Teacher Conditions and Staff Facilities
